- 1. A letter addressed to UPAAA that includes:
  - a. Intent to finish the BEED or BSED program and teach
  - b. Information of current condition of student and/or family
  - c. Other scholarships/grants received
  - d. Endorsement of Program Adviser
- 2. True copy of grades
- 3. Any of the following, if applicable:
  - a. Copy of recent ITR (photocopy or online copy) of parents and/or self
  - b. Certificate of Indigency of family
  - c. Affidavit of income of parents and/or self
  - d. Affidavit of No income of parents

#### I. Minimum Qualifications for Application

1. The applicant must be a Filipino citizen, enrolled in the University of the Philippines Diliman as a First-Year student in Bachelor of Elementary Education or Bachelor of Secondary Education.

2. Must be financially needy: that is, his/her parents' or guardians' combined annual gross income is not more than PHILIPPINE PESO:(PHP 500,000) based on their combined income tax returns in the immediately preceding calendar year.

3. In case no student applies or qualifies in the above DONOR-specified program, the UP College of Education shall consider other qualified applicants pursuing other academic programs in the College.

4. The grantee gives consent to receive communications from UPAAA, submits a photograph and a thank-you letter to UPAAA.

II. Benefits of the Award

The Award shall provide benefits of US Dollar Five Hundred (US \$500) per semester divided equally and paid over the five (5) months of the semester, during which the grantee must be actually enrolled, until he/she graduates.

#### III. Terms

A. The scholarship is renewable every semester until the recipient finishes his/her degree course, provided he/she satisfies the following conditions:

1. Must have obtained an average grade of "3.0" or better for the minimum academic load of his/her academic unit and maximum residence rule;

2. Must have no grade of "5.0".

3. Any grade of "4" or "Incomplete" must be removed or completed, respectively, on or before the last day of registration of the following competer:

or before the last day of registration of the following semester;

 Must not have been found guilty of any disciplinary action worse than a 5-day class suspension;

5. Must not shift to another course or go on leave of absence without prior approval from the UP College of Education and the UPAAA;

B. In case a grantee fails to meet any of the above conditions, the award shall be ipso facto terminated. However, the grantee may be reinstated in the semester immediately following the disqualification provided he/she satisfies the Terms under III-A of the grant. Reinstatement will be allowed only once.

C. In the event the donor decides to discontinue the scholarship, it is understood that the donor will continue to support the existing grantee until graduation, unless the grantee has been disqualified from the Program for failure to meet the retention requirements of the grant.

D. In the event the grant becomes available due to disqualification or voluntary withdrawal of a grantee, or graduation of a grantee, the Award will be offered to another qualified student in the UP College of Education.
